- Permits for PRP Stormwater Project Contract 'B' (stream restoration) have been submitted to the DEP.
- Residents affected by the stream restoration projects are working with Mr. Randy Lubin, Municipal Services Director, to sign right of way agreements.
- M-10 Mrs. Conley made the motion to Award Contract No. 22-SW1, Stormwater Improvements Pond Retrofits to Independent Enterprises, Inc. in the amount of \$483,980.00; second by Mrs. Brown. Upon vote, the motion passed unanimously.
